This Memorandum of Understanding ( hereafter referred to as MoU) is made and entered into on this day, the 2<sup>nd</sup> November, 2022 between Govt. M.M.R. Post Graduate College Champa, Dist- Janjgir Champa (CG) and Govt. College Barpali, Dist- Korba (CG)

For a period of 5 years from the academic year 2022-23 to 2026-27 for Faculty & Student Exchange.

**1. OBJECTIVES OF THE MOU:**

1. To provide the environment of knowledge sharing of both the institutions.
2. To provide interaction among the students of both the institutions.
3. To provide an opportunity to faculties and students to share knowledge on curricular, co-curricular and other activities.

**2. PROPOSED TERMS OF COLLABORATION:**

1. Both the institutions will mutually agree for guest lectures and relieve teachers of respective subject.
2. At least 15 days before, the invitation letter for the guest lectures will be sent to the teachers or they will be contacted through their mobile number.
3. No travelling expenses will be provided to teachers/students.
4. No allowances shall be paid to the visiting teachers/students,
5. All the necessary arrangement for the guest lecture will be made by the host institution,

**3. NON EXCLUSIVITY:**

Both the parties are free to pursue other agreements of any kind and the relationship of the both the parties shall be non exclusive under this MoU,

**4. TERMS OF MERMINATION:**

This MoU shall expire after 5 years by mutual written agreement of both the parties. For unilaterally terminating MoU, 60 days prior written notice will be served by either of the party.


**5. RELATIONSHIP:**



Nothing in this MoU shall be construed to make either of the parties a partner, an agent or a legal representative of the other for any purpose.


**6. OUTCOME:**


The outcome of the MoU consists of student and faculty exchange between the institutions in order to enhance the quality, academic environment in the field of education, technology and R&D.
