CODE OF CONDUCT FOR THE STUDENTS

General rules:

Every student taking admission in government / non-government colleges of Chhattisgarh will be a participant in the penal action prescribed by for following the rules of the college in letter and spirit. Ideal behavior for the students.

1. The student will come to the college in a decent dress. Under no circumstances should his costume be provocative.
2. Every student will devote his full attention to studies, as well as provide full support to the activities organized by the college.
3. He shall behave decently in the college premises, shall not use unparliamentarily language, abuse, assault or use firearms.
4. Every student shall treat his teachers, officers and employees with courtesy and kindness.
5. It is the moral duty of every student to keep the college campus clean, he will live a simple and frugal life.
6. Consumption of intoxicants of any kind will be strictly prohibited within the limits of the college and hostel.
7. Spitting here and there, providing walls or writing dirty things is prohibited in the college. Strict action will be taken if the student is found involved in anti-social and criminal activities.
8. He will not agitate his demands by spreading violence or terror. The student will keep himself away from party politics and will not take the help of political parties, workers or newspapers to get his demands convinced.
9. There will be a complete ban on the use of mobile in the college premises.

Study rules:

1. 75 attendance of the student in each subject will be mandatory and it will be N.C.C./ N.S.S. will also apply. Otherwise he will not be eligible to appear in the annual examination.
2. The student shall use the equipment in the laboratory with care. They will keep the laboratory clean. Will keep the laboratory clean and tidy.
3. Will follow the rules established by the library, he will get only the prescribed number of books and will have to pay the prescribed monetary penalty for not returning them on time.
4. He shall make a peaceful representation to the teachers or to the Principal for any difficulties related to the study.
5. Vandalism of fans, lights, furniture, electrical fittings etc. in lecture halls, laboratories or reading rooms will be considered as punishable conduct.

Exam Rules:

1. It is mandatory for the student to appear during the session. In the unit examinations, bimonthly and half-yearly examinations
2. In case of unwell and not appearing in the internal examinations, the student will produce a medical certificate from a government doctor and will take the examination after recovery.
3. Attempt to take any unfair advantage or use unfair means in or in connection with the examination shall be treated as serious misconduct.

Jurisdiction of the college administration:

1. If the student / student is found accused of any immorality oriented or serious crime, then his admission will be canceled immediately.
2. If a student is found to be involved in ragging, he shall be punished with imprisonment of either description for a term which may extend to five years, or with fine which may extend to five thousand rupees, or with both.
3. If the student does not pay the fee within the stipulated time, his/her name will be struck off.
4. If the student hides or misrepresents the facts in any application or application, then his admission will be canceled and he will be separated from the college. For taking admission in this college, it is mandatory to sign the declaration form of the parent or

Guardian in the application submitted by the student and this signature will be done in front of the admission committee.

CODE OF CONDUCT FOR THE TEACHERS

The following shall be the norms governing the code of conduct for teachers:-

- A teacher shall not make use of the resources and/or facilities of the department/college/university/governing body for personal, commercial, political or religious purposes.
- A teacher shall not be involved in the conduct/participate in private coaching classes directly or indirectly.
- A teacher shall not indulge in or resort to directly or indirectly, any malpractice or unfair means in teaching, examination and administration.
- A teacher shall furnish correct information to the best of his/her knowledge regarding his/ her qualification, experience, age etc. in respect to his/her appointment/promotion.
- A teacher shall perform his academic duties and work related to examinations as assigned by the authority.
- She/ He shall not misuse the facilities or forum of the College / University.
- A teacher shall not refuse to carry out the academic and administrative decisions taken by the Principal / governing body.
- A teacher shall not be partial in assessment of a student or deliberately over mark, under mark or victimize a students on any grounds. Also staff should submit the information on time.
- A teacher shall not conduct /participate in private Coaching classes directly or indirectly. He shall also not accept private tuitions.
- Staff should abide by the deadlines and submit correct information with knowledge of competent authority as and when required by University/ Joint Director/ any other body.
